YOUR DONATIONS TO TIBET FOUNDATION

From now on ALL your donations to us - whether large or small, regular or one-off - will be worth 22% more *at no extra cost to you.*

From the 6th April 2000, under the Government's new Gift Aid scheme, if you are a UK tax payer we can claim the tax you have already paid on any donation you make to us. So for every £1 you give we can reclaim 28p. This means a donation of £10 will be worth £12.82.

Furthermore, if you are a higher rate tax payer you can also benefit by claiming the difference between the standard and the higher rate tax band.

What do you have to do?

All you have to do is complete the form overleaf to authorise Tibet Foundation to recover the tax you have paid on your donation. This will be valid for all your future donations - or at least until you stop paying tax.

If you prefer you can make an oral declaration by telephone* or electronically via e-mail.

It's as simple as that!

Please read the notes below to ensure your donations qualify for Gift Aid relief

It does not matter what rate of tax you pay as long as you pay an amount of income or capital gains tax at least equal to the tax that Tibet Foundation reclaims on your donations in that tax year. This is currently 28p for every £1 you give.

If in the future your circumstances change and you no longer pay tax on your income and/or capital gains tax equal to the tax that we reclaim, you must cancel your declaration by notifying us.

Proceeds from fundraising events or collections are not eligible.

Other information

Please inform us if you change your name or address whilst the declaration is in force.

You can cancel the declaration at any time by notifying us. Once you have cancelled, we will not claim tax on any future donations that you may make.

**If you make an oral declaration by telephone, this will be validated by a written Declaration which we will send you. A cancellation of your oral declaration can be made within a 30 day period after you receive the written declaration from us.*
